## **Old Health Department Building: Preserve or Demolish?**

The vacant old Health Department building located at the southeast corner of Pendleton and N. St Asaph streets and occupying much of the block along the east side of N. St Asaph has been designated as surplus City property. Preparing to put the site up for sale, the City is considering whether the building should be preserved or demolished.

Because a part of the building lies within the Alexandria National Register historic district, it is a candidate for historic preservation. City Staff says that this 68-year-old two-story red brick, postwar Colonial Revival style building with its slate roof and two cupolas is clearly of “old and unusual or uncommon design, texture and material” that would be difficult to reproduce today. It has carved stone steps, leaded glass windows over the entrance, and sandstone lintels. Its size and setback from the street, with mature trees in the front yard, would help maintain the scale and character of the surrounding neighborhood, which includes Robert E. Lee’s boyhood home and some late 19th century buildings. Directly across Pendleton Street to the north is the historic Portner Brewery bottling building, part of which was retained during redevelopment.

On April 18, the Old and Historic Alexandria Board of Architectural Review voted unanimously in favor of designating the building for historic preservation. Their recommendation, though not binding, is being sent to City Council for consideration.

## **Waterfront Plan Implementation** *By Christa Watters*

Implementation of the Alexandria Waterfront Small Area Plan is proceeding. On April 14, 2012, City Council established the Alexandria Waterfront Commission to advise the Council and staff on issues related to Alexandria’s historic Potomac River waterfront and on implementation of the Waterfront Small Area Plan. The Commission replaces the Waterfront Committee, established in 1989, and expands the membership to 21, representing different neighborhoods, community organizations, or City committees.

To move ahead with Waterfront Plan implementation, at its April 17 meeting, the Commission heard presentations on

potential sites for Waterfront area Bike Share Stations and also of the Union Street Corridor Study, which will study both parking and traffic issues along the corridor, to include consideration of the conflicting needs of different kinds of traffic: automobiles, delivery trucks, bicycles, and pedestrians. The study also looks at traffic patterns, such as where the highest volume of vehicle turns occurs and in which directions.

If I told you that you could see wildlife including birds, ducks and frogs, watch airplanes take off and land, and admire murals of our Nation’s First President you might think that you’d have to head somewhere far away, right? The Harris Teeter Development, located at 735 North St. Asaph Street and bordered by Madison and Pitt Streets, has begun demolition of existing structures.

The development will build a 5-story structure housing 175 rental apartments and a Harris Teeter grocery store. Construction is planned to last through 2014, but the Harris Teeter grocery store will open prior to the final completion date, probably in late 2013.

## Friendship Firehouse Museum *By Tom Soapes*

Fire played a significant role in Alexandria's history, and some of that story is on display at the Friendship Firehouse Museum (107 S. Alfred St.). The fire company was established in 1774 as a volunteer company. Firefighters had to pay dues to belong to the company, which did not supply uniforms. The current Friendship Firehouse was built in 1855, and renovated in 1992. It was one of several fire companies protecting the city in the 19th century.

Open flames were a daily fact of life in Alexandria into the early twentieth century for cooking, heating, and industrial purposes. Open flames in a town with many wooden buildings created a substantial and continuous fire hazard. The city suffered its most devastating fire in 1827, when a fire destroyed Green's Furniture Factory (Prince and S. Royal Streets) and 53 other buildings. Damage was estimated at \$127,000. In 1855, arsonists started a fire in which seven firefighters died at the Dowell China Factory, 215-217 King Street. The arsonists were never caught.

The museum also documents other major blazes in 1871 and 1922. On May 12, the museum will offer a walking tour (fee charged) highlighting firehouses and fiery events in Alexandria history. The museum also sponsors a Father's Day Open House and, in August, a Firehouse Festival ([www.alexandriava.gov/historic](http://www.alexandriava.gov/historic)) and is available for special events, including children's birthday parties. Open Saturdays and Sundays 1:00 - 4:00, admission charged.

## Printers' Row Town Houses Making Progress *By Christa Watters*

The 20-town-house development (with a condo ownership structure) known as Printers Row at 1125 North Royal Street is finally in active construction after years of delay. Steve Weatherby, vice president of construction at Holladay Corporation of Washington, DC, was on site on April 11 to confirm the company is targeting completion by year's end or early 2013.

Jessica Sterchi, an associate at the firm, confirmed that the first units are expected to be delivery-ready by fall. The town houses will average 2,500 square feet, with most units having 3 bedrooms, though a few will have only 2. The development will be in a contemporary industrial/warehouse style with brick facades, but the units facing Royal Street will have somewhat more traditional fronts to blend with the adjacent Hearthstone Mews community.

The development includes one small retail building, a 1900-square-foot unit on the corner of North Fairfax and Third Streets. Below grade parking with two spaces per town house. Holladay Corporation also developed Liberty Row and Abingdon Row in North Old Town.
